# **COMMITTEE MEMBER REPORTS**

Chair's Report

• Recharter status 2014- 6 adults have been contacted as to if they are continuing. They have said no, or didn't respond. Adults that will be registered with the troop: 28, 7 of these are paying themselves. Currently the number of Scouts registering is 40ish.

#### Scoutmaster's Report-

Sam Battistella has registered as an adult. He is in the process of planning his Eagle Ceremony. Jim Battistella is re-registering, will also submit for a grant for the troop from AllState (last year it was used for equipment).

Our Troop, along with other local troops, has been invited on Monday January 13 to Kenmore Presbyterian Church for a demonstration by Praxair involving Cryogenics, starting @ 7:00.

Assistant Scout Masters this year: Sam Battistella and Justin Dibble will become Asst. Scout masters. Losing a number of scouts- (Max Franklin, Dan Barry, Rob Mol, Austin Oetinger will not be returning at this time.) Some of these scouts may qualify for the special consideration if they choose to attend events.

### **Eagle Status Report**

- Dibble, Justin Finished his project, emailed copy to Mike Brylinski, last merit badge was completed. He is ready for Scout masters conference
- Parker, Brandon Project summary was submitted to committee, Brandon will be making some changes to his project proposal. Brandon presented his project ideas to the committee tonight. He hopes to start within a month or 2, and should be getting funding from his church for the project. Brandon will be talking to his church council about this soon.

#### **Finance Report**

• Treasurer-Patrol Campout is settled. (\$39 to good), RoughRider is settled, (in the good). Bowling cost was \$249, \$330 was budgeted.

Popcorn is still being settled, money is still coming in. The cost to troop was \$275, but \$375 had been budgeted. A \$40 Walmart card was earned to give to the troop.

• Bottle Return- An untapped source of revenue in this area and in the area by St. Amelia's. Lisa Gilmartin spoke about getting the boys involved for bottle return drives to be coordinated around holidays (Superbowl, St. Patrick's Day, 4<sup>th</sup> of July/Graduations). Boys would get \$10 credit to participate for handing out flyers, and \$10 for pickup of cans and bottles the following week. 1 week pass out fliers, next week pick up. Bottle Junction is now open (corner of Colvin and Brighton) and will provide plastic bags. They would come and pick up bags, only glass to be sorted into cardboard boxes. It was suggested that each boy that participates gets a set sum of money, the rest of the money could be used for troop extras, or to be put toward a large Troop purchase. The

routes are already made in the St. Amelia's area. This will be kept on the agenda- proposal to start when weather gets better.

# Quartermaster's Report

• Jambo Gear Status- received shipment, 5 tents, 4 lanterns, 2 stoves; 2 cots were missing. 1 tent had bad poles. Replacement tent will be sent at no extra charge.

#### **Program Report**
