- Congi- Report has been put in, Eagle application has been sent in. Mike B is waiting for confirmation from Council. He will schedule a BOR upon confirmation from Council. Finance Report
- Treasurer- payments for NYC trip are going out, summer camp payments are coming in. Looks like certain areas are running under budget (ex. Awards). Weekend campouts are under budget. Zombie Camporee may be over budget. Mike asked about budget for camping gear. Would like to be reimbursed for a stove he bought for Philmont. (approximately \$88). This \$ will come out of the gear budget- approved.

## **Prorating Dues**

- 1. For calculation of Troop 286 dues, August will be considered the beginning of the program year and fiscal year. July of the following year will end the program year and fiscal year.
- 2. Troop 286 Dues will be prorated on the basis of the months when program is run, generally September June.

Program will be considered by:

- a. Regularly scheduled and run weekly troop meetings
- b. Monthly weekend scheduled camp outs or other designated events (such as Lasertron Lock in)
- 3. For calculation of prorated Troop 286 dues, these will be determined by the first **full** calendar month.
- 4. Webelos crossing over will be granted a 1 month waiver for Troop 286 dues. (NOTE: Webelos moving up at the end of May would pay July dues schedule. Webelos moving up at the end of February would pay April dues schedule.)
- 5. Scouts aging out will have their Troop 286 dues prorated based on August start date for the fiscal year. This takes precedent over the previous age-out policy.
- 6. Dues/registration should be paid in full by the first troop meeting in December. This allows for a major fundraiser to be completed and for dues to be paid from the proceeds. It also acts as a grace period for anyone that might be considering whether to continue.
- 7. BSA Registration cost is based on the calendar year.
